### Invitation for Bids

#### **IMPROVEMENT OF SEWERAGE SYSTEM AT DISTRICT GENERAL HOSPITAL – GAMPAHA (Contract No. WP/DB/CON/20/100)**

1. The Chairman, Deputy Chief Secretary (Engineering)'s Procurement Committee on behalf of the Secretary, Ministry of Health (WP) will receive sealed bids for **Improvement Of Sewerage System at District General Hospital – Gampaha** as described below and estimated Direct Construction Cost **Rupees One Hundred Seventy Million Three Hundred Eleven Thousand Five Hundred Thirty Two. (Rs.170,311,532.00)**

The Works consists of improvement of the Sewerage Treatment Plant , Construction of a 300 m<sup>3</sup>under ground tank ,rehabilitation of sewer manhole network etc. The construction period is 238 Calendar days from the date of award of the contract.

2. Bidding will be conducted through National Competitive Bidding Procedure.
3. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall meet the following requirement.
  - Construction contractors who are registered with the CIDA for grade EM1 or above in the field of plumbing and Drainage and **C6 or above** in the field of Water supply and sewerage/Storm Water disposal and Land Drainage.  
(If a sub-contractor is introduced for “Building and Civil Engineering” category/ “Electrical Mechanical Services” category, all the required documents relevant to the qualification information should be furnished along with the bid)
  - Business Registration.
  - Bidder shall have been registered under the Public Contract No 03 of 1987 and the Certificate of Registration should be submitted along with the Bid.
4. Post Qualifications of the bidder required to qualify for contract award include:
  - Successful and timely completion and commissioning of two projects with similar scope and complexity and minimum construction cost of **Rupees One Hundred thirty (130) Million** during the last five years, as a main contractor.
  - Average annual value of turn over from construction work performed during the last five (5) years shall be at least **Rupees Three HundredNinety (390) million**.
  - The minimum amount of liquid assets and/or credit facilities, after setting apart for the other contractual commitments and exclusive of any advance payments which may be made under the contract , shall be not less than **Rupees Sixty Four (64) Million**.

inspect the bidding documents at the same address from 9.00 hrs to 15.00 hrs during normal working days.

6. A complete set of Bidding Documents in English language may be purchased by interested bidders on submission of a written application to the **Divisional Engineer's Office, No. 50, Courts Road, Gampaha** from 23.11.2020 until 11.12.2020 from 0900 hrs to 1500 hrs upon payment of a non refundable fee of **Rs.15,000.00**. The payment shall be paid in cash to the Accountant of this office.
7. Sealed bids addressed to **Chairman, Deputy Chief Secretary (Engineering)'s Procurement committee, Engineering Organization (W.P)** shall be delivered to the **Divisional Engineer's Office, No. 50, Courts Road, Gampaha** on or before at 1130 hrs on 14.12.2020. Alternatively sealed Bids may be dispatched by registered post to the **Divisional Engineer's Office, No. 50, Courts Road, Gampaha** before closing time. Late bids will be rejected.
8. Bids will be opened immediately after the closing at the same venue in the presence of the authorized representatives.
9. All bids shall be valid up to **91 (Ninety One)** days after the deadline for bid submission.
10. All bids shall be accompanied by a bid security to the value of **Rs.2,000,000/= (Two Million only)** address to the **Deputy Chief Secretary (Engineering) -WP, Engineering Organization, 204, 5<sup>th</sup> Floor, Denzil Kobbakaduwa Mawatha, Battaramulla** as per the format given in Section 2 of the Bidding Document. Bid security shall be valid up to **119 days** after the dead line for bid submission. Any bid not accompanied by a valid Bid security will be rejected.
11. A Pre-bid meeting will be held on 07<sup>th</sup> of December 2020 at 10.00 hrs at the District General Hospital - Gampaha.
