



## **Invitation for Bids**

### **Western Provincial Council of Western Province Engineering Organization**

#### **Design, Construction and Completion of proposed Sewerage Treatment Plant For District General Hospital - Gampaha**

- 1) The Chairman, Procurement committee of the Deputy Chief Secretary (Engineering), Engineering Organization Of Western Provincial Council of Western Province invites sealed bids from eligible and qualified bidders for **Carry Out Necessary Designs and Constructions for Development of Existing Sewerage Treatment Plant in District General Hospital – Gampaha.**
- 2) Bidding will be conducted through National Competitive Bidding Procedure on Single stage two envelop method.
- 3) The eligible bidders (individual, firm or joint venture) shall comply with the following preliminary qualification requirements.
  - a) The Bidder shall not have been blacklisted
  - b) Having CIDA registration of Grade EM 3 for electrical & Mechanical services and Grade C4 or above in building construction and sewerage & water supply .(*If the bidder has no experience in design and build projects on its own, it may enter in to a partnership or joint venture with Engineering Consultants / Firms for the design portion of the contract.*)
  - c) Should have a business registration as a consultancy firm/company in Sri Lanka.
  - d) Bidder shall have been registered under the Public Contract No 03 of 1987 and the Certificate of Registration should be submitted along with the Bid
- 4) The eligible bidders (individual, firm or joint venture) shall comply with the following post qualification requirements.
  - a) Availability of Chartered Civil Engineers, Chartered Structural Design Engineers, Chartered Electrical Engineers and Chartered Mechanical Engineers who have carried out similar assignments in the past.

- b) Average of the annual turnover of construction work performed in last five years as at the date of closing of bids shall be not less than **230 Million** rupees.
  - c) Experience in Construction and Completion of a two sewerage projects of similar nature and complexity (at least sewerage projects with capacity of 25m<sup>3</sup> per day) with a project value of not less than **Rs.100 Million** completed during last five years.
  - d) The bidder shall have experience of successful completion of at least five sewerage projects or more within last five (05) years.
  - e) The minimum amount of liquid assets and/or credit facilities (after setting apart for other contractual commitments) and exclusive of any advance payment which may be made under this Contract shall be **not less than Rs. 37 Million**.

- 6) A complete set of Bidding Documents in English Language may be purchased by interested Bidders on Submission of a written application to the Engineer, Procurement Unit, Engineering Organization, 5<sup>th</sup> Floor, Western Provincial Council, 204, Denzil Kobbekaduwa Mawatha, Battaramulla from 15.01.2021 to 03.02.2021 from 09.00 hrs to 15.00 hrs during normal working days upon payment of a non-refundable fee of Rs.5,000.00. The payment shall be paid in cash.
- 7) Bids shall be valid up to 91 days from the date of closing of the Bid.
- 8) All bids must be accompanied by a bid security conforming to **section I** of Instruction to Bidders for an amount of Sri Lanka Rupees **Two Million (LKR 2,000,000.00)**, issued by one of the agencies indicated in **clause 16.2** of Instruction to Bidders. Bid security shall be **valid up to 119 days** from the date of bid closing.
- 9) Sealed completed bids in duplicate shall be deposited in to the Tender Box made available at **Procurement Unit, Engineering Organization, 5th Floor, Western Provincial Council, 204, Denzil Kobbekaduwa Mawatha, Battaramulla**. or sent by registered post to reach on or before 11.30 am on 05.02.2021 . *(General Information with “Technical proposal” (Envelop 1) and “Price proposal” (Envelop 2) in two separate envelops enclosed in single envelop should be submitted. Late bids shall be rejected. (Bids (Envelop1) will be opened soon after closing of the bid in the presence of the bidders or their authorized representatives).*

10) Total Design and construction period is 250 calendar days.

11) A Pre-bid meeting will be held on 22<sup>nd</sup> of January 2021 at 10.00 hrs at the District General Hospital, Gampaha.
