## SUPPLY, INSTALLATION, TESTING AND COMMISSIONING OF FIRE DETECTION & PROTECTION

TO "NILA PIYASA" OFFICIAL QUARTERS FOR PUBLIC OFFICERS IN GAMPAHA DISTRICT (PHASE II)

- 1.The Chairman, Procurement committee of the Deputy Chief Secretary (Engineering), Engineering Organization of Western Provincial Council of Western Province on behalf of the Secretary, Ministry of Public Services, Provincial Councils & Local Government invites sealed bids from eligible and qualified bidders for the Supply, Installation, Testing and Commissioning of Fire Detection & Protection System to "Nila Piyasa" Official Quarters For Public Officers in Gampaha District (Phase II) with estimated cost Sri Lankan Rupees Five Million and Two Hundred Seventy Seven Thousand Four Hundred (SLR 5,277,400.00) (Excluding VAT). The construction period is 70 Calendar days from the date of award of the contract
- 2.Bidding will be conducted through National Competitive Bidding Procedure.
- 3.To be eligible for contract award the successful bidder shall not have been black listed and shall meet the following requirements:
  - ➤ The bidder shall have experience of successful completion of at least five installations of fire systems or more within last five (5) years in similar nature and complexity.
  - ➤ Make and model of the fire system offered shall have satisfactory service record in Sri Lanka for at least last five (05) years.
- 4.Post Qualification requirements to qualify for contract award include:
  - Average annual turnover of construction work performed in the last five years shall be at least **Rs. 17.5 Million.**
  - > Successful completion as main contractor of a construction project of similar nature and complexity with a project value at least **Rs.4 Million** and or a higher project value, completed during last ten years.
  - > The minimum amount of liquid assets and/or credit facilities (after setting apart for other contractual commitments) and exclusive of any advance payments which may be made under this contract shall be not less than **Rs.4.5 Million.**
  - ➤ Bidder should have been registered under the Public Contract No.03 of 1987 and the Certificate of Registration should be submitted

The method of payment will be in cash.

7.Sealed bids shall be delivered in duplicate to the address below at **the Deputy Chief Secretary** (Engineering), Engineering Organization (WP), 204, 5<sup>th</sup> Floor, Denzil Kobbakaduwa Mawatha, Battaramulla before 2.00 p.m on 08.10.2021 Late Bids will be rejected. Bids will be opened soon after closing in the presence of the bidders' representatives who choose to attend.

8.Bids shall be valid up to 63 days from the opening of bids.

- 9. All bids shall by a Bid Security which shall be:
