2. I. “Bidding will be conducted through National Competitive Bidding (NCB). Since the Total Cost Estimate of this procurement (excluding VAT and other taxes) is below Rs.50Mn., regional Preference and CIDA grade preference shall apply as stipulated in Public Finance Circular No.04/2016(iii).”
 II. Public Finance Circular No 03/2020(i) is entitled to this Procurement and, “If the State Owned Enterprises (SOE) are quoted for bids, five percent (5%) preference will be given.”
3. To be eligible for contract award, the successful bidder shall not have been black listed or assigned contracts should not be defaulted or not completed in given time period beyond bidders control or terminated pre maturely and shall meet the following requirements and Qualifications should be fulfilled as in the Bidding Document.

Late Bids will be rejected.

8. Bidder shall have been registered under the Public Contract No 03 of 1987 and the Certificate of Registration should be submitted. (As in the Column No.05 of the table)
