



## Invitation for Bids

### Western Provincial Council of Western Province Engineering Organization

#### **Design, Supply, Installation, Testing, Commissioning and handing over of Proposed Sewerage Management System for the Office of the Medical Officer of Health (MOH) at Piliyandala**

- 1) The Chairman, Deputy Chief Secretary (Engineering)'s Procurement Committee on behalf of the Secretary, Ministry of Health (WP) now invites sealed bids from eligible and qualified bidders for "*Design, Supply, Installation, Testing, Commissioning and handing over of Proposed Sewerage Management System for the Office of the Medical Officer of Health (MOH) at Piliyandala*" as described below.
  - The proposed work includes Design, Supply, Installation, Testing, Commissioning and handing over of Proposed Sewerage Management System.
  - The Direct Construction Cost is Rs. Mn. 4.5.
  - The construction period is 105 Calendar days.
- 2) Bidding will be conducted through National Competitive Bidding procedure on two-envelop method.
- 3) The eligible bidder shall comply with the following preliminary qualification requirements.
  - a) The Bidder shall not have been blacklisted
  - b) Having valid registration as a Consultant/Specialist for technical guidance on water/pollution control in Central Environmental Authority.
  - c) Should have a business registration as a consultancy firm/company in Sri Lanka.
- 4) The eligible bidders shall comply with the following post qualification requirements.
  - a) The bidder shall have qualified experienced personnel in his staff capable of planning, engineering, installing Commissioning and maintaining of similar or higher capacity *Sewerage Management System* installations.
  - b) Average of the annual turnover of construction work performed in last five years as at the date of closing of bids shall be not less than **Rs.23 Million** rupees.
  - c) Experience in Construction and Completion of a two sewerage projects of similar nature and complexity (at least sewerage projects with capacity of **2.5 m<sup>3</sup> per day**) with a project value of not less than **Rs.3.5 Million** completed during last five years.
  - d) The bidder shall have experience of successful completion of at least five sewerage projects or more within last five (05) years.

- e) The minimum amount of liquid assets and/or credit facilities (after setting apart for other contractual commitments) and exclusive of any advance payment which may be made under this Contract shall be **not less than Rs. 3.5 Million.**

- 6) A complete set of Bidding Documents in English Language may be purchased by interested Bidders on Submission of a written application to the Engineer, Procurement Unit, Engineering Organization (W.P.), 5<sup>th</sup> Floor, 204, Denzil Kobbekaduwa Mawatha, Battaramulla from **08.05.2024 to 28.05.2024** from **09.00 hrs to 15.00 hrs** during normal working days upon payment of a non-refundable fee of Rs.3,000.00. The payment shall be paid in cash.
- 8) Bids shall be valid up to 63 days from the date of closing of the Bid.
- 9) All bids must be accompanied by a bid deposit of Sri Lanka Rupees **Twenty Two Thousand Five Hundred (LKR 22,500.00)** in cash or a bid security conforming to **Section I** of Instruction to Bidders for an amount of Sri Lanka Rupees **Forty Five Thousand (LKR 45,000.00)** in favor of Deputy Chief Secretary (Engineering), Engineering Organization (W.P.), 5<sup>th</sup> Floor, No 204, Denzil Kobbekaduwa Mawatha, Battaramulla as per the format given in Section 5 of the Bidding Document. Bid security shall be issued by one of the agencies indicated in **clause 16.1** of Instruction to Bidders and it shall be **valid up to 91 days** from the date of bid closing.
- 10) Sealed completed bids (Volume 1A, Volume 2 & Volume 3) in duplicate shall be deposited in to the Tender Box made available at **Procurement Unit, Engineering Organization (W.P.), 5th Floor, 204, Denzil Kobbekaduwa Mawatha, Battaramulla.** or sent by registered post to reach on or **before 10.30 am on 29.05.2024** . *(General Information with “Technical proposal” (Envelop 1) and “Price proposal” (Envelop 2) in two separate envelops enclosed in single envelop should be submitted. Late bids shall be rejected. (Bids (Envelop1) will be opened soon after closing of the bid in the presence of the bidders or their authorized representatives).*
- 11) A Pre-bid meeting will be held on **16<sup>th</sup> of May 2024** at **10.00 hrs** at the MOH office, Piliyandala.
